Century Arms is proud of the craftsmanship that goes into manufacture the VSKA rifle and backs this firearm with a LIMITED LIFETIME WARRANTY.

Please review the warranty policy below and contact Century Arms Customer Service if your rifle needs repair. Each rifle has a unique serial number which will be required to obtain warranty service.

## LIMITED LIFETIME WARRANTY

Your Century Arms rifle is warranted against defects in materials and workmanship for the serviceable life of the product. If we cannot repair your rifle, we will replace it with a rifle in equal or better physical condition.

This warranty does not cover loss, theft, deliberate damage, corrosion, neglect, abuse or unreasonable use, misuse, defects or malfunctions resulting from misuse, ammunition failures or use of defective or improper ammunition, lack of maintenance, nonfactory part installations, alterations or modifications to the firearm, disassembly beyond the field stripping instruction sin the product's manual (where applicable), normal or ordinary wear and tear, criminal misuse, negligence, use under the influence of drugs or alcohol, or cosmetic damage that does not hinder the performance of the product.

All warranty claims are processed through Century Arms Customer Service. If you are returning a rifle for warranty service, please email <a href="mailto:support@centuryarms.com">support@centuryarms.com</a> with your serial number. If approved, a Return Authorization Number (RAN) will be provided.

Any and all warranties, written or implied, are void with any alterations to the rifle including cosmetic refinishing.

The VSKA Limited Lifetime Warranty is available to original purchasers from a federal firearms license holder. Product registration is required to activate warranty. A serial number must be provided to initiate repair service.

## WARRANTY SERVICE PROCEDURE

Please send the VSKA Product Registration form within 30 days of purchase to register your VSKA rifle with Century Arms. Proof of purchase, including a receipt or invoice, must be provided with your registration. Forms may be submitted either by certified or registered mail, or via electronic mail, to the address provided on the form.

To obtain warranty service, you must return your rifle to Century Arms. Do not attempt to return your rifle to Century Arms without first contacting the company.

You can contact Century Arms by email at <a href="mailto:support@centuryarms.com">support@centuryarms.com</a> or via the company website at the address <a href="https://www.centuryarms.com/contacts">https://www.centuryarms.com/contacts</a>. An Authorized Century Arms Representative can determine if Century Arms factory service is required and how to proceed.

If your rifle must be returned to the Century Arms factory, you will be responsible to pay the freight charges to Century Arms. Before any rifle is returned to Century Arms, you must get a Return Authorization (RA) number from us. Rifles returned to Century Arms without an RA number may be denied warranty service.

When the VSKA rifle is received by Century Arms it will be inspected to determine if it is a proper claim for warranty repair. Century Arms will pay the freight charges to return the repaired rifle to the owner's FFL of choice. Century Arms is not responsible for transfer fees at the FFL.
